**FROM THE McDONOUGH COUNTY HEALTH DEPARTMENT:** The Illinois Department of Public Health (IDPH) and McDonough County Health Department (MCHD) announce that one McDonough County resident has tested positive for COVID-19. The patient is a male in his 40's and CDC protocols have been implemented. Public health officials are working to identify and actively monitor individuals who were in contact with the patient in an effort to reduce the risk of additional transmission.

**FAMILY CLINIC HOURS CHANGE:** Starting on Monday, April 13, the MDH Family Clinic will change its hours of operation. The new hours Monday through Friday are from 8 a.m. until 5 p.m. This new schedule **DOES NOT** change the MDH Convenience Clinic hours.

**DRIVE-THRU SCREENING STATION RELOCATION THIS WEEKEND:** Due to potential inclement weather in the forecast this weekend, the MDH drive-thru screening station is relocating temporarily. Starting Saturday morning, the canopy at the main entrance to the hospital will be utilized as the drive-thru screening station. Patients can enter from the East side as they do now and depart out the West. Patients **MUST PRE-REGISTER** through the MDH nurse triage hotline at (309) 836-1715.

**NEW MOLECULAR TESTING OPTION FOR PROVIDERS:** The MDH Laboratory announced new molecular viral respiratory testing to assist in ruling out potential SARS-COV-2 diagnoses during this COVID-19 pandemic. These new tests are all FDA approved on all age groups. Running a Viral Respiratory Panel would allow providers to rule out such diagnoses as: Influenza A & B, RSV, and Human Metapneumovirus.

According to Laboratory Director Brittany Doll MS, HTL (ASCP), "If the patient requires COVID-19 testing, in addition to a Viral Respiratory Panel, we collect a single nasal pharyngeal swab in viral transport media (VTM). This specimen alone is enough for us to run all the required tests. Additionally, we can employ reflex methodologies with the lateral flow immunoassays currently utilized. For example, if a "Rapid Influenza Standard" or "Rapid RSV" is ordered, and comes back initially as negative, we can run the VRP. This will either verify the negative result, or disprove the less sensitive test initially performed and conclude a positive result. We had that situation occur where a test was initially negative but after running a VRP the test came back positive for Influenza."

**TELEHEALTH SERVICES AVAILABLE:** McDonough District Hospital has expanded outpatient TeleHealth services amid the current COVID-19 pandemic to better serve its patients. MDH providers will utilize a program called Doxy.me for a video visit with their patients. There is no software to download or accounts to create with this new TeleHealth service. All that a patient needs is a computer or device with a camera and microphone. All the data is encrypted and no patient information is stored on Doxy.me. All HIPAA privacy requirements are met with this new service. Patients with questions about the TeleHealth service can call their respective clinic.
