"We are very pleased to announce that we will be resuming elective surgeries and procedures on Monday (May 11). Many people have worked very hard in order to ensure that this is being done safely both for our patients and for our staff. Procedures will be preceded by COVID testing 72 hours prior to the procedure. Follow-up screening on the morning of the procedure will also be performed with questioning about symptoms and a check for fever. We believe that we can protect the safety of all of our patients because of our thorough screening at the tent prior to entering the building and scheduling procedures at wider intervals to protect social distancing. We thank the community for your patience in the intervening time. We look forward to serving you further in the future."

**AS A REMINDER WHILE INDOORS:** According to the Governor's Executive Order in relation to Public Health Requirements for Individuals Leaving Home and for Businesses - wearing a face covering in public places or when working... Any individual who is over age two and able to medically tolerate a face covering (a mask or cloth face covering) shall be required to cover their nose and mouth with a face covering when in a public place and unable to maintain a six-foot social distance. **Face coverings are required in public indoor spaces such as stores**.

**HEALTH DEPARTMENT UPDATE (www.mchdept.com):** The McDonough County Health Department (MCHD) announced on Friday two additional McDonough County residents have tested positive for COVID-19, bringing the total number of positive cases to 48. Centers for Disease Control and Prevention (CDC) protocols have been implemented. Public health officials are working to identify and actively monitor individuals who were in contact with the residents in an effort to reduce the risk of additional transmission. Due to Federal privacy restrictions, the release of any additional information on these cases is prohibited.

**NATIONAL NURSES WEEK:** MDH celebrated National Nurses Day on May 6, kicking off National Nurses Week which runs through May 12. Thank You to all the nurses - everyone at McDonough District Hospital and those nurses throughout McDonough County - for your dedication and service to patients.

**RECOVERED CASES AT FOUR:** The McDonough County Health Department announced now four recovered cases from COVID-19. Recovered is defined by the CDC as resolution of fever without fever-reducing medications for three (3) days (72 hours), improvement of respiratory symptoms, and at least seven (7) days have passed since symptoms first appeared. The MCHD will continue to update on the amount of recovered cases in the county.
